#### PARTICULARS OF THE PROGRAMME

- **Participation Fee:** ₹10,000/- (inclusive of refreshments).
- **Accommodation:** Outstation participants are required to arrange their own stay.
- **Duration:** 15 days of classroom training; attendance on all days is compulsory.
- **Batch Size:** Minimum 30 and maximum 50 participants; registration on a *first-come, first-served* basis.
- **Daily Schedule:** Two sessions each day, from 10:00 a.m. to 5:30 p.m.
- **Dress Code:**
  - **Inaugural Day, Valedictory Session & Project Report Presentation:** Formal suit or full-sleeve white shirt with dark-colored trousers and a matching tie (for both male and female participants).
  - **Other Training Days:** Formal dress attire is mandatory. (Jeans, tops, long Skirt & T-shirts are not permitted)
- **Programme Flexibility:** Duration may be altered, extended, or changed depending on other programmes of ICSI-NIRC; participants must adhere to such modifications.
- **Schedule Confirmation:** The schedule is tentative; written confirmation must be obtained from NIRO before joining.
- **Withdrawal Policy:**
  - Participants unable to join must inform in writing at least 5 days prior to commencement.
  - In case of cancellation by the candidate, refund will be processed as per applicable training guidelines.
