The venue and contact person details of ICSI Mega Placement Drive – May, 2022 are as under:

MODALITIES:

- Eligibility:** The members who got their ACS membership on or after 1st January, 2021 are eligible to participate in the drive.
- Eligible members are compulsorily required to pay a registration fee of Rs 500/- (REFUNDABLE) for participating in Placement Drive, which shall be refunded in full to all candidates, except those who have not appeared in the Mega Placement Drive for any reasons.
- Prior registration is mandatory for participation in the Mega Placement Drive.
- Placement opportunities are open on all India basis, hence Eligible Members may participate in Mega Placement Drive at any Region of the ICSI.
- The Institute reserves the right to call limited number of candidates during the process in case large number of applications received.
- Mere registration for the Placement Drive by filling up the registration form does NOT guarantee selection or interview of any candidate.
- Canvassing for selection in the Placement Drive would lead to disqualification.
- Rejection of offers without valid reason would bar a member from participating in other Placement Drives being organized by the Institute for the current year.
