A Peer Review is directed towards maintenance as well as enhancement of quality of attestation services and to provide guidance to members to improve their performance and adhere to various statutory and other regulatory requirements.

Peer Reviewed PCS have been acknowledged to undertake the increased number of Secretarial Audit/Secretarial Compliance reports. In this direction, the Council of the Institute has issued several guidelines focusing the importance of Peer Review of PCS and specifying clearly that going forward only Peer Reviewed PCS shall be allowed to undertake Secretarial Audit of the Companies and Secretarial Compliance Report under SEBI (LODR) of listed companies.

As the need for Peer Reviewed PCS is increasing, there is an enhanced need to equip the Peer Reviewers with Peer Review techniques, procedures and the skills required for conducting peer reviews.

Member of the Institute desirous of being empanelled as a Peer Reviewer shall fulfill the following criteria:-

- Be a member with at least 10 years of experience post qualification as Company Secretary
- Be currently holding Certificate of Practice as issued by the Institute;
