

"ICSI GURUSHRESHTHA AWARDS 2023"

Process of submitting entries and Selection of winners for the Award

A.) Introduction

The purpose of "GURUSHRESHTHA AWARDS" is to celebrate the immense contribution of the finest teachers in the country and to honour those Professors/Faculties who through their dedication and commitment, have not only improved the quality of education but also enriched the lives of their students.

ICSI introduced "GURUSHRESHTHA AWARDS" in the year 2022 to commemorate the significant contribution of the faculties/Professors. This initiative of ICSI was applauded by teaching fraternity and all academicians. Keeping in view the success of "GURUSHRESHTHA AWARDS-2022", ICSI is conducting "GURUSHRESHTHA AWARDS" in the year 2023 also.

i) Conditions of eligibility of faculties for consideration for the Awards:

- a) All faculties (Asst Professors, Associate Professors and Professors) who are working as permanent faculty on full-time regular basis in Department of Commerce, Management and Law of such Universities, are eligible to apply; irrespective of the fact whether he /she is teaching to undergraduates (UG) or post graduates(PG).
- b) All faculties (Asst Professors, Associate Professors and Professors) who are working as permanent faculty on full—time regular basis in Department of Commerce, Management and Law of affiliated college / constituent college are also eligible to apply; irrespective of the fact whether he /she is teaching to undergraduates (UG) or post graduates (PG).
- c) The award category is as under -

- d) If any faculty is teaching in more than one department, in such case he/she is allowed to apply under either of one category only. Please specify one category as per choice of applicant in the application format.
- e) It may further be noted that the winners of "GURUSHRESHTHA AWARDS-2022" held in the year 2022 are not eligible to apply for the "GURUSHRESHTHA AWARDS-2023".

ii) Evaluation process.

a) Applicants are requested to submit the application format (as given at Annexure -II) duly filed and signed by applicant along with desired information as mentioned in Annexure-II (including part A and part B) along with all supported enclosures.

- b) 1st level evaluation will be done by the ICSI academic team and expert group comprising of academicians constituted under ICSI Gurushreshtha Award.
- c) The candidature of top 5 (five) applicants shortlisted by ICSI academic team and expert group in each category shall be placed before the Jury. Jury will have an online interaction with all five shortlisted candidates in each category. The weightage of interaction with the jury will be 50 marks. Thereafter, the winner and 1st Runner -up in each category will be declared.
- d) The winners will be declared based on the evaluation done by the jury as per details given below.

iii) Procedure for application and selection of winners:

- a.) ICSI has developed a questionnaire to evaluate the faculties. A rigorous process has been followed to develop the questionnaire and eminent educationalists were involved in designing and framing the questionnaire.
- b.) To evaluate the faculties, the questionnaire (Annexure-1 comprising of part A and part B) will be sent by email (also hard copy by post) to the concerned universities and will also be uploaded at the website of the Institute. Interested faculty may take print out the same, fill in all the details in application form given at Annexure -II, enclose required supporting documents and send it to ICSI-HQ at the address given at point no (d) below.
- c.) If desired documentary evidence is not submitted, the marks will be deducted appropriately.
- d.) All the applications shall be received in hard copy only. Applications along with supporting documents such as documents, tools, reports of activities, photographs, flyers, pamphlets, links of audios or videos etc. are to be sent in physical form at the following address.

- e.) While sending entries, kindly ensure that all the supporting documents are enclosed along with desired application format (given at Annexure -II) only. Entries without desired documents will be summarily rejected. Further, the supporting documents must be verified/authenticated by the HOD of the respective Department as per details given in the questionnaire. Candidates are also required to send a certificate issued by HOD of their respective Department authenticating his/her designation, pay scale, date of birth, Department and discipline. Entries without desired documents, certificate will be summarily rejected.
- f.) The required enclosures must be enclosed as per the sequence given in the questionnaire (Annexure-1 including part A & part B) and proper indexing is to be done for smooth evaluation process.
- g.) Applicant is to attach a forwarding letter issued by HOD of concerned department / Principal of College along with his/her application and all supporting enclosures.

- h.) Self-attestation is to be done by the applicant on each page of his/her application and all supporting enclosures. Without self-attestation, the application will not be considered.
- i.) The cut-off date to submit the applications (hard copies only) along with supporting documents is 10th December 2023. Hard copies should reach at the address mentioned above latest by 10th December 2023. Please note that the entries received after 10th December 2023will not be considered for evaluation and shall be summarily rejected.
- j.) **Declaration by the applicant:** Each applicant shall give declaration that all the information/data submitted is true to the best of his/her knowledge and if anything is found at any later date to be untrue then his/her nomination will be cancelled and suitable action will be taken.
- k.) There is no upper limit on no. of applications to be received from any University.

B.) Evaluation

1.) Expert Group:

- a.) First level scrutiny will be done by Expert group comprising academicians of premier educational bodies.
- b.) The major functions to be performed by the Expert group are as under:
 - 1.) Designing and development of questionnaire for evaluating the faculties
 - 2.) Verification of the facts/information provided by the applicant.
 - 3.) Evaluation/marking of the applicants as per the format at Annexure-I.
 - 4.) After the detailed evaluation of the applications, Expert group will shortlist 5 names in each Sub category i.e Commerce, law and Management of each category and forward these to the Jury.

2.) The esteemed Panel of Jury

To evaluate the entries at second level, ICSI has formulated the jury of eminent academicians in the country. The major functions to be performed by the Jury are as under:

- 1.) Interaction with the shortlisted candidates in each category.


