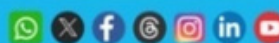

Competition-wise Rules & Regulations

This document lays down the detailed rules and regulations for each competition proposed and approved under Yuvotsav 2026 – National Conference of Student Company Secretaries. These rules shall be uniformly applicable unless specifically modified by the WIRO.

GENERAL RULES (APPLICABLE TO ALL COMPETITIONS)

- Participation is open only to registered ICSI students with valid identity proof.
- A participant may participate in multiple competitions, but shall manage their own schedule.
- Reporting time and time limits must be strictly adhered to.
- Judges' and WIRO decisions shall be final and binding.
- Use of unfair means, plagiarism, indiscipline or misbehaviour shall lead to immediate disqualification.
- Certificates and prizes shall be awarded by the WIRO.
- Rules may be modified by the WIRO in the interest of smooth conduct of the event.
