### **Theme**

#### Role of CS in Viksit Bharat@2047

The Theme encapsulates the future of Company Secretaries: their contribution, involvement and influence on the overall development of our nation. The essence lies in a greater sense of responsibility towards delivery of service, redrawing and revisiting the goals towards nation development as a professional, in order to achieve excellence thereby embodying enhanced knowledge and improved value engagement. At the Conference, the learned speakers shall take us through various aspects of avenues of growth leading towards future changemakers in four technical sessions.

#### **Thematic Sessions**

- CSR Contribution of Corporates for Development of the Nation: "In a free enterprise, the community is not just another stakeholder in business but is, in fact, the very purpose of its existence."- JRD Tata. Corporate Social Responsibility is integral to any business, regardless of its size. CSR incorporates purpose into an organization's basic philosophy and objective in order to aid broader societal problems, which is critical for development of the society as a whole. We are indeed well aware that CSR initiatives have the potential to significantly strengthen the economy at the core. As Company Secretaries in Practice, there is immense potential in terms of contributing towards curbing overall economic divide, advising on implementation of effective CSR, thematic areas to be adopted and policy making covering the complete CSR journey. The session shall guide on how the Company Secretaries can leverage their ability of influencing implementation of good governance in the CSR mechanism of the Company.
- FDI Catalyst for India's Colossal Growth Role of PCS: Foreign direct investment (FDI) is an integral part of an open and effective international economic system and a major catalyst of development. According to the World Investment Report 2023, India emerged as the FDI powerhouse and secured the third-highest foreign investment in FY 2021-22. India has become an attractive destination for FDI with various schemes and policies that have helped boost India's FDI. These schemes have prompted India's FDI investment, especially in upcoming sectors such as defence manufacturing, real estate and research & development. Apart from nurturing the compliance environment, there are several underlying opportunities for Company Secretaries in Practice such as advising on Modes and Structure of Capital inflows, advising on effective utilisation of funds for maximum profits, adjudication and handling critical non-compliances, etc. This session is conceptualized to have focused deliberations on the role of Company Secretaries in FDI Regime considering the journey towards Viksit Bharat.
- Leveraging the potential of Startups, Fintech and MSMEs: Startups and Micro, Small, and Medium enterprises (MSMEs) are the backbone of the Indian economy, significantly contributing to employment generation and GDP growth. With a burgeoning ecosystem of Startups and established players, from digital lending platforms streamlining credit access to innovative payment solutions enhancing efficiency, the adaptation of Fintech solutions is reshaping MSME paradigms. Fintech solutions have revolutionised the financial services sector in India by addressing long-



standing challenges and unlocking opportunities for growth. With the rapid digitization, these fintech firms are trying to bridge the urban-rural divide to foster financial inclusivity. The enhanced focus on these sectors has also enhanced opportunities for the Company Secretaries in terms of guiding and advising for economic and social development, the session focusses on the same.

• Governance Mantras from Ramayana for Corporate World - Guiding Light for Growth of the Nation: India is home to long history of tradition, culture and values. Ancient Scriptures are the source of treasure and wisdom, Upanishads, Vedas and Epics epitomize ethics at the centre stage all of the deeds and conduct. The Ramayana has many lessons that can be applied to modern Corporates. The story of Lord Rama's leadership, his decision-making process and his ability to build consensus can all be seen as relevant to the challenges faced by corporates today. The modern-day corporates realise that prioritizing governance fosters organizational integrity and success and the governance principles encapsulated in Ramayana offer insights into effective Corporate Governance practices. ### ATTRACTIONS AT AYODHYA

Ayodhya is an ancient city of India situated on the banks of Sarayu river in the state of Uttar Pradesh. It is among the principal religious centres of India and is the birthplace of Lord Rama- principal deity of Hinduism.

#### Major attractions include:



Shri Ram Janma Bhoomi Temple: It is a Hindu Temple Complex in Ayodhya, UP. The temple was inaugurated on 22<sup>nd</sup> January, 2024 and is considered to be the birthplace of Lord Rama, the principal deity of Hinduism.

Hanuman Garhi: Located in Sai Nagar, Hanuman Garhi is a 10<sup>th</sup> century temple dedicated to the Hindu God, Hanuman. It is one of the most important temples in Ayodhya as it is customary to visit Hanuman Garhi before visiting the Ram Temple in Ayodhya. It is believed that Lord Hanuman lived at the temple site guarding Ayodhya.





Kanak Bhawan: The Kanak Bhawan is established towards the north eastern corner of the Ram Janmabhoomi in Tulsi Nagar. Constructed in 1891, this temple is also known as Sone-ka-Ghar. It is a holy site dedicated to the Hindu deity Lord Rama and his wife, Goddess Sita.

Nageshwarnath Temple: Established in the name of the local deity, Lord Nageshwarnath, the Nageshwarnath Temple is located adjacent to the Theri Bazaar in Ayodhya. It is believed to have been set up by Kush, Lord Rama's son.





Ram ki Paidi: Ram ki Paidi is a series of ghats on the bank of River Saryu. The river front brings forth an outstanding Landscape especially in floodlit night. These serve as platforms to devotees who it is said, come to wash away their sins by taking a dip in the river.

Gulab Bari: One of the most popular tourist attractions of Faizabad, the Gulab Bari is a charming lush green garden, home to the magnificent tomb of Nawab Shuja-ud-Daula, the third nawab of Avadh, who ruled between 1753 and 1775. This tourist stopover is noted for its wide variety of roses, which draw nature lovers and botanists from all parts of the country. Gulab Bari was used to host significant religious functions during the nawab's reign. Built in the Islamic style of architecture, the imposing tomb is one of the best designed monuments in Uttar Pradesh.
