**ORDER**

(1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00062 on 07.05.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref No. ICSOI/R/E/24/07896 dated 29.04.2024 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.

(2) The Appellant vide his application dated 06.04.2024 has requested to provide reply to following:

1. How many candidates applied for verification/ inspection/ certified copies.
2. Also provide statistics of how many students got change in result- increase in marks, how many got no change in result and how many got reduction in marks For CS professional Attempt, December 2023.

(3) The Appellant has informed in the instant appeal that “Refused access to information requested”.

(4) The reply of the Respondent against the instant appeal is as under: -

“1. It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/24/07896 dated 06.04.2024, was provided to the Appellant vide letter dated 29.04.2024.

2. Further, the information sought by the Appellant regarding statistical data of marks obtained under verification/inspection/certified copies was not provided as it is still under process and has not been finalized.

3. Furthermore, no interim data is maintained and the final data is to be provided after the completion of process.

The contents as above made in the RTI reply stands as it is and are candid.

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

1. Query No 1 has been replied vide letter dated 29<sup>th</sup> April 2024.
2. For Query No 2, CPIO (EXAM) to provide data after completion of the process.
