## Object of the Programme

CS Professionals appearing before NCLT are required to learn about rules, interpretation of NCLT rules in lines of judicial pronouncements, so as to make them confident in representing the matters and keeping them familiar with legal proceedings.

Sessions also includes important procedures and working knowledge in major and emerging areas of NCLT practice.
