• RBI's FAQ on guidelines for digital lending: Key details (February 14, 2023)

In an FAQ on guidelines for digital lending, the RBI said on February 14, 2023 that in the event of a loan turning delinquent, the lender must give the borrower the details of the recovery agent before the agent comes visiting. Besides, the lender also needs to provide the borrower the names/details of empanelled agents at the time of sanctioning the loan. Only those agents are authorised to contact the borrowers when there is a default on the loan, the document said.
