e-Shram portal showcased during 112th International Labour Conference at Geneva, Switzerland (June 19, 2024)

Ministry of Labour & Employment launched e-Shram portal on 26th August 2021 for creation of a comprehensive National Database of Unorganised Workers, authenticated with Aadhaar. As on 18th May 2024, 29.67 over crore unorganised workers have already been registered on e-Shram portal. The portal is presently integrated with National Career Service (NCS) Portal, Skill India Digital Hub (SIDH), myScheme portal and Pradhan Mantri Shram Yogi Mandhaan (PMSYM) scheme.

Invitation of applications for recognition of Self-Regulatory Organisations (SROs) for NBFCs (June 19, 2024)

The Reserve Bank had issued 'Omnibus Framework for recognition of Self-Regulatory Organisations for Regulated Entities of the Reserve Bank' dated March 21, 2024, wherein broad parameters, viz., objectives, responsibilities, eligibility criteria, governance standards, application process, etc., were specified. It was also stated that other sector-specific guidelines like number of SROs, membership, etc., shall be issued separately whenever a sectoral SRO is intended to be set up. It has now been decided to invite applications for recognition of SROs for the NBFC sector under the aegis of the aforesaid omnibus framework. The applicant entity shall fulfil the eligibility criteria and guidelines mentioned under the omnibus framework. Interested applicants seeking recognition as an SRO may submit their application through email (cgmicdor@rbi.org.in) or to the Chief General Manager-in-Charge, Department of Regulation, Reserve Bank of India, Central Office, 2nd Floor, Main Office Building, Shahid Bhagat Singh Marg, Mumbai – 400 001 by September 30, 2024. India now 3rd-largest domestic airline market; capacity doubles in 10 yrs (June 19, 2024)

India is the third-largest domestic airline market in the world, up from number five position a decade ago, according to analysis based on OAG data. The data shows India's domestic airline capacity doubling in a decade from 7.9 million in April 2014 to 15.5 million in April 2024. In reaching the third slot, India has replaced Brazil (pushed to fourth place with 9.7 million) and Indonesia (relegated to fifth in the rankings with 9.2 million). The US (86.1 million) and China (67.8 million) are still far ahead in the game holding the top two positions. India's capacity growth rate of seats over a 10 year average is the highest amongst the top five countries, growing at 6.9 per cent annually, followed by China at 6.3 per cent, the US at 2.4 per cent, Indonesia by 1.1 per cent and Brazil experiencing an annual decline of 0.8 per cent.
