**ORDER**

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00069 on 19.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/03449 dated 18.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 27.02.2023 has requested to provide photocopy of answer sheet for CS Executive Programme, Session: December 2022 Examination Subjects: PAPER 1: JURISPRUDENCE, INTERPRETATION & GENERAL LAWS (421) PAPER 2: COMPANY LAW (422) PAPER 3: SETTING UP OF BUSINESS ENTITIES AND CLOSURE (423) PAPER 4 : TAX LAWS (424) PAPER 5: SECURITY LAWS & CAPITAL MARKET (426) PAPER 6: ECONOMIC BUSINESS AND COMMERCIAL LAW (427)
- (3) The Appellant has informed in the instant appeals that "Details not provided."
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/03449 dated 27.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 18.03.2023 and once again on 07.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 20.04.2023.

Appellant is requested to check his registered email ID.
