## ORDER

The same is also made known to all the candidates while enrolling for the examination. Therefore, the contents of the reply to the RTI query stands as it is and are candid.
- This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 7. This Office concurs with the submissions of the Respondent as above.

The appeal is accordingly dismissed.
