ORDER

- The Appellant has filed first appeal dated 24th June, 2018 (received in this Office on 27th June, 2018) under section 19(1) of the Right to Information Act, 2005 against information provided vide letter Ref. No. RTI 2005/2039(18) dated 16th May, 2018 by the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. In this appeal, the Appellant has requested for condoning the delay in submission of the appeal due to health issues, which has been accepted.
- 3. In his appeal, the Appellant has informed that he is not satisfied with the replies furnished by the Respondent against his queries.
- 4. The Respondent had informed the Appellant against query 'a' that the requisite information is available on the Institute's website and the Appellant may get the hard copy of information (5 pages) on remitting Rs.10/- @Rs.2/- per page. The Appellant has informed that he has already remitted additional amount of Rs.10/- at the time of submitting his RTI request.
- 5. The Respondent has informed that in the appeal, the Appellant is raising new queries against queries 'b', 'd', 'e', 'f', 'g', 'h', 'i' and 'l'. The Respondent has submitted that the Appellant may lodge fresh RTI requests for the same.
- 6. The Respondent has further informed that at query 'c', the Appellant is giving his suggestion which cannot be construed as information.

- 7. The Respondent has further informed that queries 'j' and 'm' are not information as defined under Section 2(f) of the RTI Act.
- 8. The Respondent has further informed that queries k' and n' are ambiguous.
- 9. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 10. The Respondent is directed to send hard copy of information sought at query 'a' within 15 days from the date of issue of this order, as the Appellant has informed that the additional amount as remitted by him may be used for the purpose.
- 11. This Office concurs with the submissions of the Respondent on all other queries raised by the Appellant.

The appeal is accordingly disposed of.
