

ORDER

1. The Appellant has filed first appeal dated 12th August, 2018 (received in this office on 14th August, 2018) under section 19(1) of the Right to Information Act, 2005 against information provided vide letter Ref.No. RTI 2005/2052(18) dated 13th June, 2018 by the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant has claimed that the delay in filing the appeal due to late receipt of the RTI response i.e. on 13/07/2018. No proof on this account has been submitted by the Appellant.
3. In this appeal, the Appellant has informed that he has not received a satisfactory response against his RTI application within the timelines.
4. The Respondent had informed that the information as sought by the Appellant is exempted under Section 8(1)(j) of the RTI Act.
5. The Respondent has further submitted that the information as sought relates to personal information, the disclosure of which has no relationship to any public activity or interest, hence, exempted under Section 8(1)(j) of the RTI Act, 2005. The content as above made in RTI reply stands as it and are candid.
6. The facts as noted from that communication submitted are:
 - (i) There is no delay by the Respondent in responding to RTI query.
 - (ii) There is delay on the part of the Appellant in filing the appeal.

7. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
8. This Office concurs with the submissions of the Respondent as above.

The appeal is accordingly dismissed.
