**ORDER**

1. The appellant had filed an appeal dated 29<sup>th</sup> September, 2016 received in this office on 4<sup>th</sup> October, 2016 under Section 19(1) of the Right to Information Act, 2005 (hereinafter referred to as "RTI Act") in response to the information supplied vide letter bearing No. RTI 2005/1690/(16) dated 23<sup>rd</sup> September, 2016 by the Central Public Information Officer (hereinafter referred to as "Respondent") of The Institute of Company Secretaries of India, ICSI House, 22, Institutional Area, Lodi Road, New Delhi-110 003.
2. I have carefully considered the application, the response, the appeal and the records made available to me and I find that the matter can be decided based on the material available on record.
3. In this appeal, the appellant has requested for releasing the information/ documents pertaining to Mr. G C R Jaiswal which has not been released by the respondent.



4. The respondent has informed that reply to RTI application dated 28<sup>th</sup> August, 2016 was furnished on 23<sup>rd</sup> September, 2016 that it relates to personal information the disclosure of which has no relationship to any public activity or interest and hence exempted under Section 8(1)(j) of the RTI Act, 2005.
5. The respondent has further informed that in accordance with 11(1) of the RTI Act, a letter dated 16<sup>th</sup> September, 2016 has been written to the third party (Mr. G C R Jaiswal) inviting him to make submission(s) as to whether the information as sought by the appellant should be disclosed or not. The third party did not make his submissions for disclosure of the information as sought by the appellant. Hence the respondent is unable to provide the information.

After careful consideration of the appeal and the response issued by the respondent, I find that the information sought by the appellant is related to personal information of third party held by the Institute and releasing the same may cause unwarranted invasion into the privacy of third party.

The appeal is accordingly dismissed.
