

ORDER

1. The appellant has filed first appeal dated 24th June, 2017 (received in this office on 3rd July, 2017) under section 19(1) of the Right to Information Act, 2005 against the response issued vide letter dated 30th May, 2017 by the Central Public Information Officer (CPIO) (hereinafter referred to Respondent) of the Institute of Company Secretaries of India.
2. In this appeal, the appellant has requested for certain information pertaining to Dr. G C R Jaiswal.
3. The respondent vide letter dated 30th May, 2017 had informed the appellant that the information as sought by him is personal information the disclosure of which has no relationship to any public activity or interest and hence exempted under Section 8(1)(j) of the RTI Act, 2005.
4. The respondent has further informed that a letter under Section 11 of the RTI Act was sent to Dr. G C R Jaiswal as per the correspondence address available in the records of the Institute. The respondent has further informed that, as per the information obtained through internet, a letter under Section 11 has also been sent to Dr. G C R Jaiswal at the address of Dr. Ram Manohar Lohia Avadh University, Faizabad wherein he was holding the post of Vice Chancellor.

5. The respondent has further informed that no response has been received from Dr. G C R Jaiswal against both the letters issued under Section 11 of the RTI Act.
6. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
7. Keeping in view the above, this Office finds that the appellant has sought personal information the disclosure of which has no relationship to any public activity or interest, and it may cause unwarranted invasion of the privacy of the individual.

The appeal is accordingly dismissed.
