4. An opportunity was given to the appellant for presenting his case in person on 25^h August, 2017 and the appellant availed the opportunity and made his

submissions on all the queries raised by him.

5. During the hearing, the appellant has requested for the budget and actual expenditure for the financial years 2015-16 and 2016-17 under the head 'Brand Building'. He has further requested for expenditure under this head made during the said years for various activities in electronic and print media, seminars/conferences (with information on break-up of expenditure in ICSI premises or in rented premises, if available) and career counseling.
