ORDER

1. The Appellant has filed first appeal dated 27th September, 2017 (received in this office on 9th October, 2017) under section 19(1) of the Right to Information Act, 2005 against information provided vide letter dated 7th September, 2017 by the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.

2. In this appeal, the Appellant has requested for providing the facts of complaint filed by CS Sidhartha Murarka against CS Sunita Mohanty for Professional

Misconduct in the year 2015.

3. On the status of complaint, the Respondent has informed that the complainant in the disciplinary case has withdrawn the complaint and copy of Order passed by the Board of Discipline of the Institute has already been provided to the

Appellant.

4. On the facts of the complaint, the Respondent has informed that the complainant (CS Siddhartha Murarka) in the disciplinary case had inter-alia alleged that the respondent (CS Sunita Mohanty) in the disciplinary case had violated Clause (6) of Part I to the First Schedule of the CS Act, 1980 and the Guidelines for advertisement by Company Secretary in Practice.

- This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. This Office has noted that a copy of the Order issued by the Board of Discipline(The ICSI) has already been provided to the Appellant. Further, the Respondent has issued clarifications on the specific provisions of CS Act and Guidelines and the same are a part of Para 4 of this Order.

The appeal is accordingly disposed of.
