## ORDER

- The Appellant has filed first appeal dated 19th November, 2019 under section 19(1) of the Right to Information Act, 2005 against response issued vide letter Ref. No. RTI 2005/2412(19) dated 27.09.2019 by the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 29.08.2019 had requested for copies of the answer books for the session June, 2019 in respect of his examination appearance in three subjects of Professional Programme Stage viz. (i) Advance Company Law and Practice, (ii) Secretarial Audit, Compliance Management and (iii) Due Diligence and Corporate Restructuring, Valuation and Insolvency.
- The Respondent had furnished the said information to the Appellant vide letter dated 27.09.2019.
- The Appellant in the instant appeal has requested that "kindly re-examine my Module-1 of CS Professional as I found mistakes in checking the Module-1"

- The Respondent has informed against the instant appeal that for verification of answer book(s), candidates have to apply within 30 days from the date of declaration of result.
- 6. The Respondent has further informed that the letter dated 27.09.2019 was delivered to the Appellant on 30.09.2019 and the first appeal has been filed on 19.11.2019 i.e. after the stipulated period of 30 days. Therefore, without going into the merit of the appeal, it should be dismissed.
- 7. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 8. This Office concurs with the submissions of the Respondent.

The appeal is accordingly dismissed.
