**ORDER**


1. The appellant has filed first appeal dated 13<sup>th</sup> February, 2017 (received in this office on 21<sup>st</sup> February, 2017) under section 19 (1) of the Right to Information Act, 2005 against the response issued vide letters dated 31.01.2017, 11.11.2016 & 11.01.2016 by the Central Public Information Officer (CPIO) (hereinafter referred to Respondent) of the Institute of Company Secretaries of India.
2. I have carefully considered the application, the response, the appeal and the records made available to me and I find that the matter can be decided based on the material available on record.
3. In this appeal, the appellant has requested releasing various information pertaining to Ms. Srestha Dhar as available in the records of the Institute.



4. The respondent vide had informed the appellant that the information as sought by him relates to personal information the disclosure of which has no relationship to any public activity or interest and hence exempted under section 8(1)(j) of the RTI Act, 2005.
5. The respondent has submitted that the third party i.e. Ms. Srestha Dhar has informed not to disclose the information as sought by the appellant.
6. The respondent has also quoted the Order of Central Information Commission (CIC) vide Ref. No. CIC/CC/A/2014/002812/BS/10542 dated 09.06.2016.

After careful consideration of the appeal and the response issued by the respondent, this office concurs with the submission of the respondent that the information sought is exempted under Section 8(1)(j) of the RTI Act.

The appeal is accordingly dismissed.
